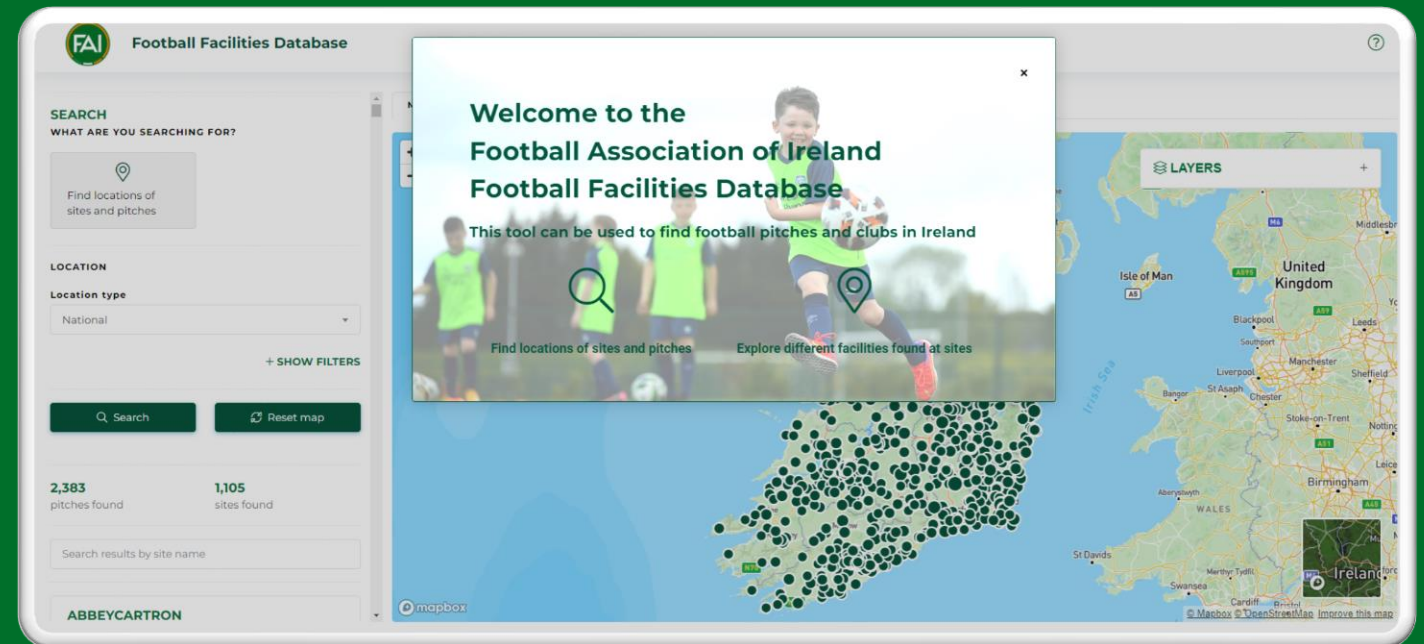
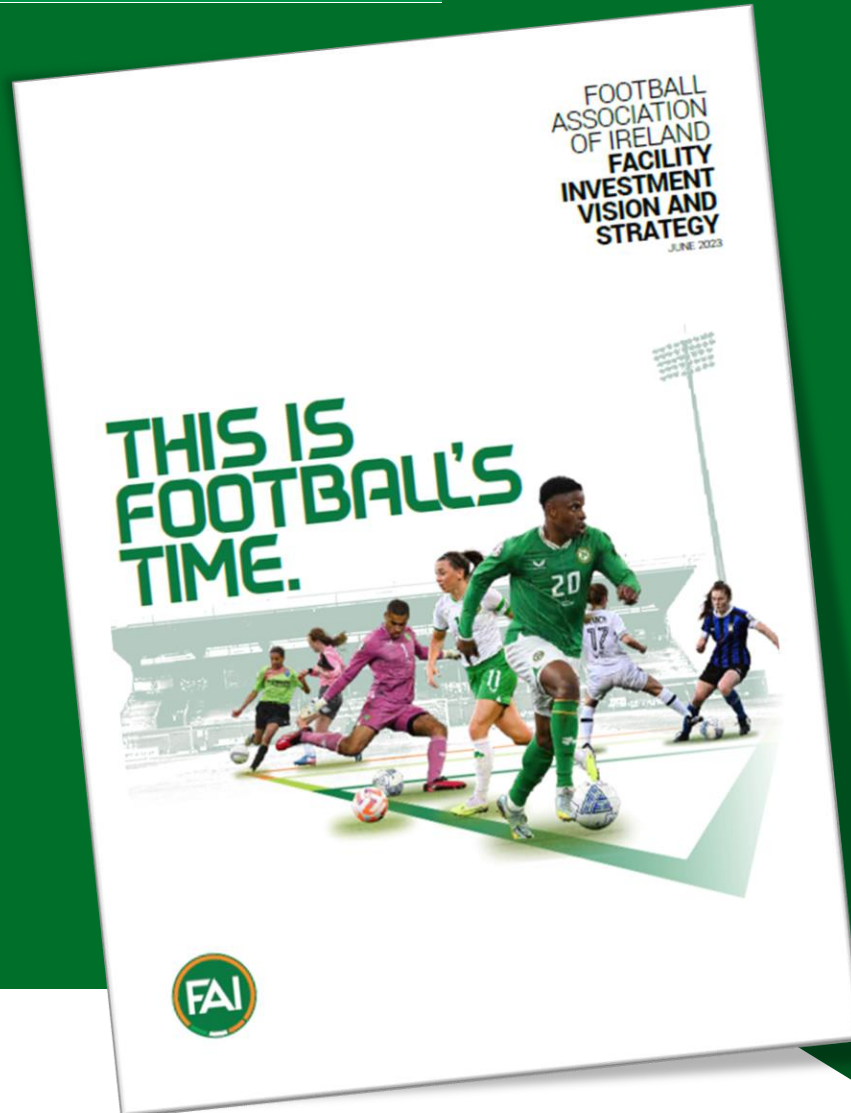

WHY APPLY? OUR VISION...

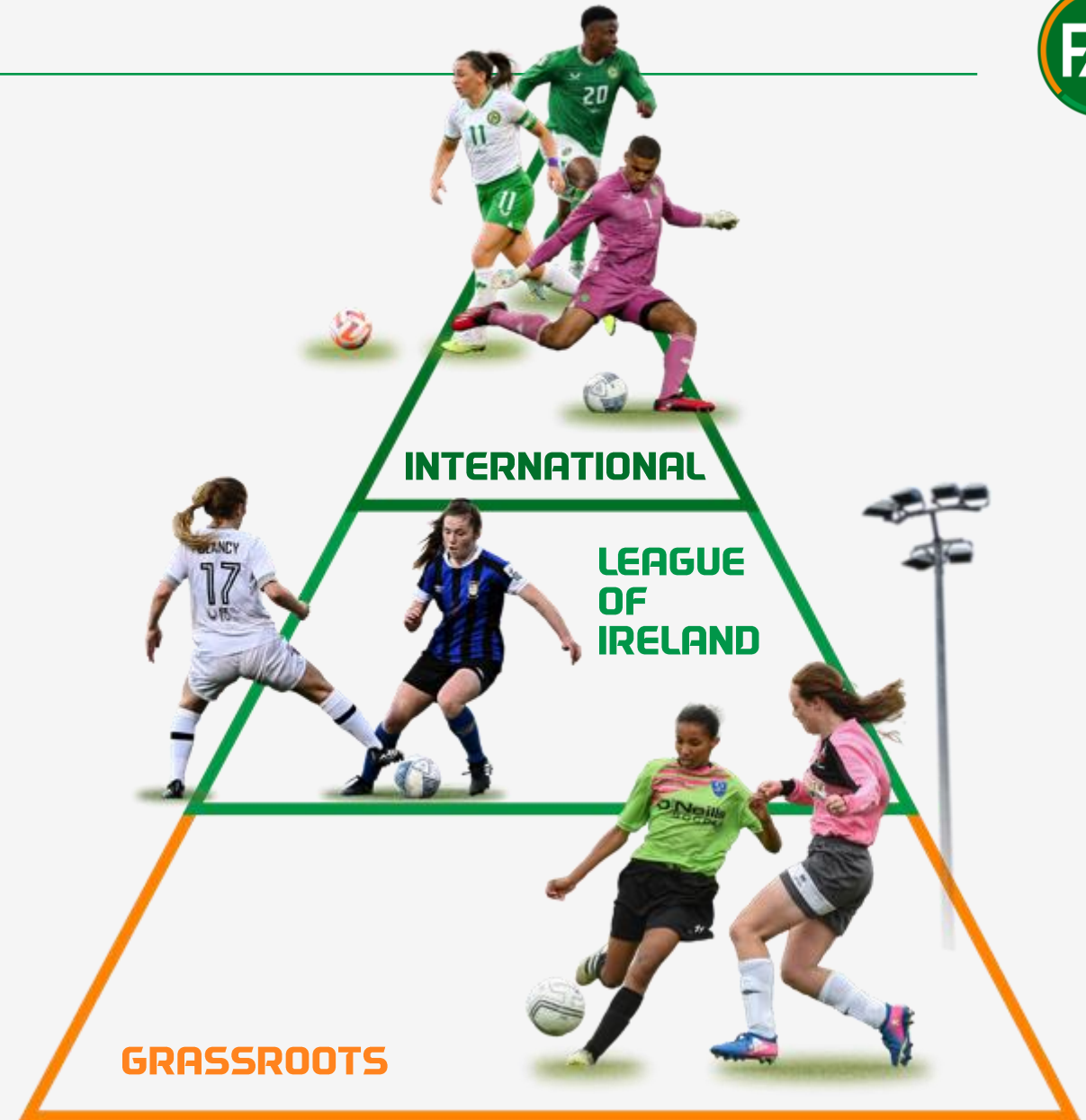


Our vision is to create infrastructure and facilities that enable Ireland's number one sport to thrive and deliver a truly transformational impact for Irish football and Irish society.

But we can only do this with the support of central and local government...

Sports Capital & Equipment Programme (SCEP) is one of these funding supports, and we urge all football clubs to apply for funding...

Without your applications, we cannot make the impact needed...



WHY APPLY? Our vision...



Our vision is to continue to develop football from the ground up, building on our status as the most popular participation sport in Ireland, by harnessing the powerful role grassroots clubs play within their communities.

To do this we need to deliver the fundamentals of a well-run and well-equipped community football club in a financial and environmentally conscious manner, which will need to incorporate:

- A fit-for-purpose supply and mix of grass and artificial pitches to meet demand, with at least one floodlit pitch in each facility
- High-quality infrastructure such as new goalposts and pitch maintenance equipment, all properly secured
- Safe and accessible changing room facilities (for both genders), with appropriate toilets and functioning showers for players and officials
- Basic food and beverage facilities, with communal spaces attached, allowing for indoor football and other sports to be played as well as community activity

WHAT WE NEED:



New grass pitches and upgrades to existing pitches



New artificial pitches and upgrades to existing pitches



New Floodlights



New and upgraded clubhouses and changing rooms (for all).



More community-ready facilities

The FAI Grassroots Club Mark scheme will be at the heart of these changes, with every club needing to have the Club Mark by the end of 2025, to ensure proper use and oversight of any new monies for facility development

Standardised facilities at the heart of local communities, which deliver a positive and lasting impact and can be scaled up depending on the size of the individual club and are developed to be environmentally sustainable and future-proofed.

WHY APPLY? The Survey Feedback

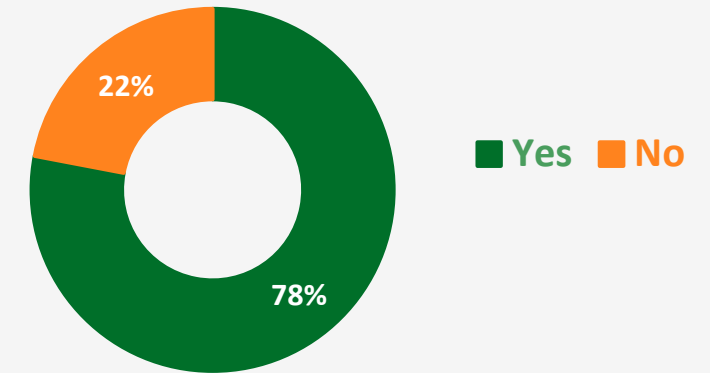


40% of our grassroots clubs have not yet accessed the SCEP fund.

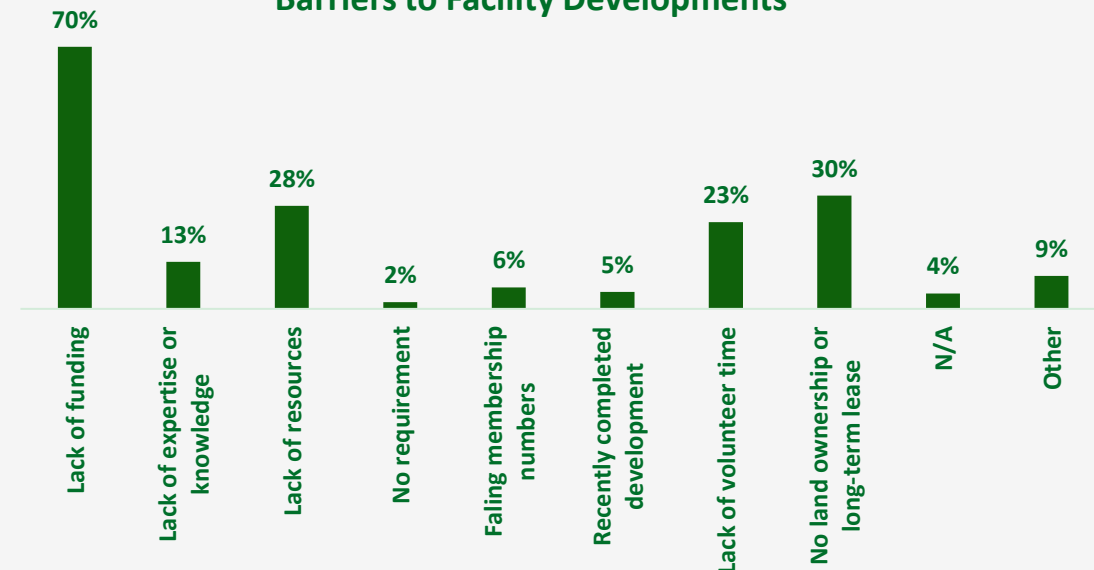
Our Facilities Survey clearly showed the appetite to increase standards but highlights the significant challenges that need to be addressed:

- Too many of our grassroots clubs do not have any form of community-focused clubhouse - only 10% of clubs have access to an indoor hall, limiting the ability of clubs to act as genuine community hubs.
- 55% of clubs do not own their facilities and rely on leases. Half of these leases are for less than 15 years.
- 27% of clubs have leases for less than one-year meaning general financial uncertainty and instability.
- 31% of clubs are required to operate out of secondary facilities in order to meet the required pitch demand for training and matches which undermines the desire for a true community experience.
- Women's football has experienced exponential growth. However, of the 670 clubs who offer women and girls football 60% have less than five teams, indicating that general capacity challenges are holding back growth in this key area.

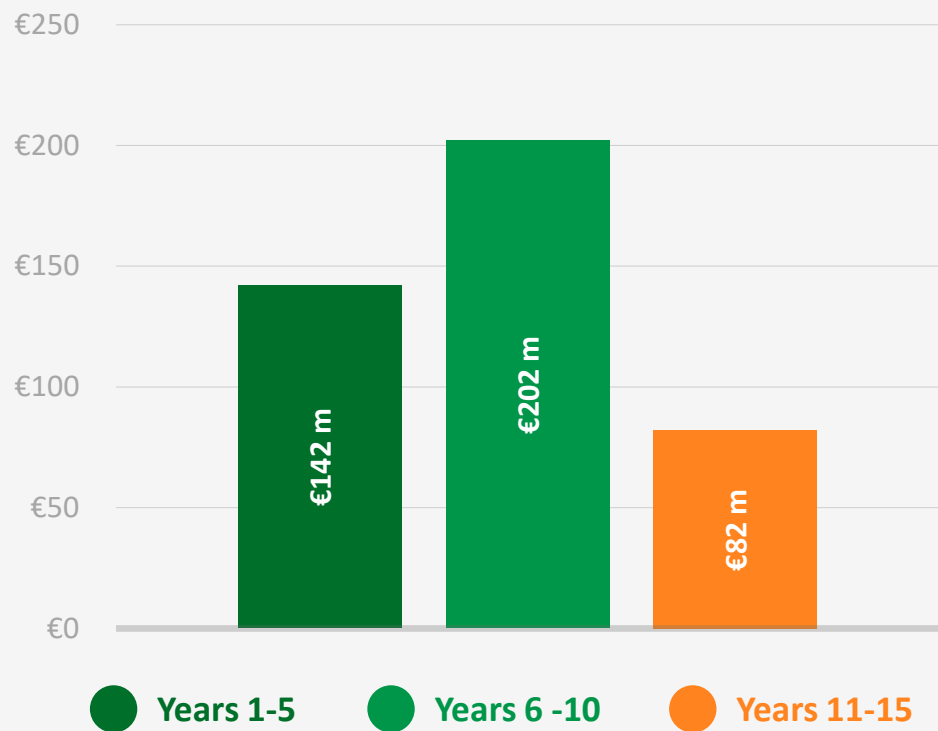

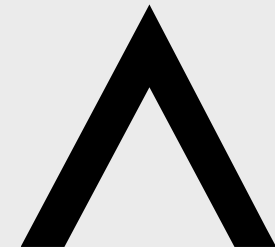

What is Sports Capital (SCEP)

“The Sports Capital & Equipment Programme (SCEP) is a grant scheme to assist in the development of sports facilities and the provision of sports equipment throughout the country.”

Funding Available:

- **Capital Works:**
 - Up to a Max: **€200,000** (must have at least 15-year lease remaining)
- **Capital Works (Short Lease):**
 - Up to a Max: **€70,000** (Lease between 5-15 years remaining)
- **Equipment:**
 - Equipment grants of **€70,000**
- **Capital plus Equipment:**
 - Up to a Max: **€200,000** (must have at least a 15-year lease remaining)

Grants awarded are up to 95% funded!

Create a project plan on your submission:

- ✓ Review all your active projects and select the most appropriate one for your application.
- ✓ Multiple projects must be prioritised.
- ✓ Not all submissions need to be major developments – do it in phases.
 - ✓ i.e. Pitch renovations, floodlights, etc.
- ✓ Equipment grants is a great alternative if you do not own the land - €70,000!

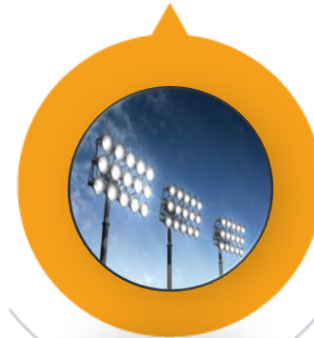

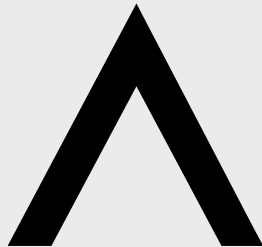
Learn from past mistakes:

1. **Title/Access Requirements – 55% of failures.**
 - title/access templates (appendix 4 and 5) have not been provided, amended, not signed, not dated or not fully completed
2. **Evidence of Own Funding – 21% of failures.**
 - loan offer or bank statements not provided, provided without the applicant's name or not dated within 3 months of the application deadline.
3. **Insufficient own funding – 8% of failures.**
 - Project not suited to budget of Club/League
4. **Applications started too late and ran out of time!**

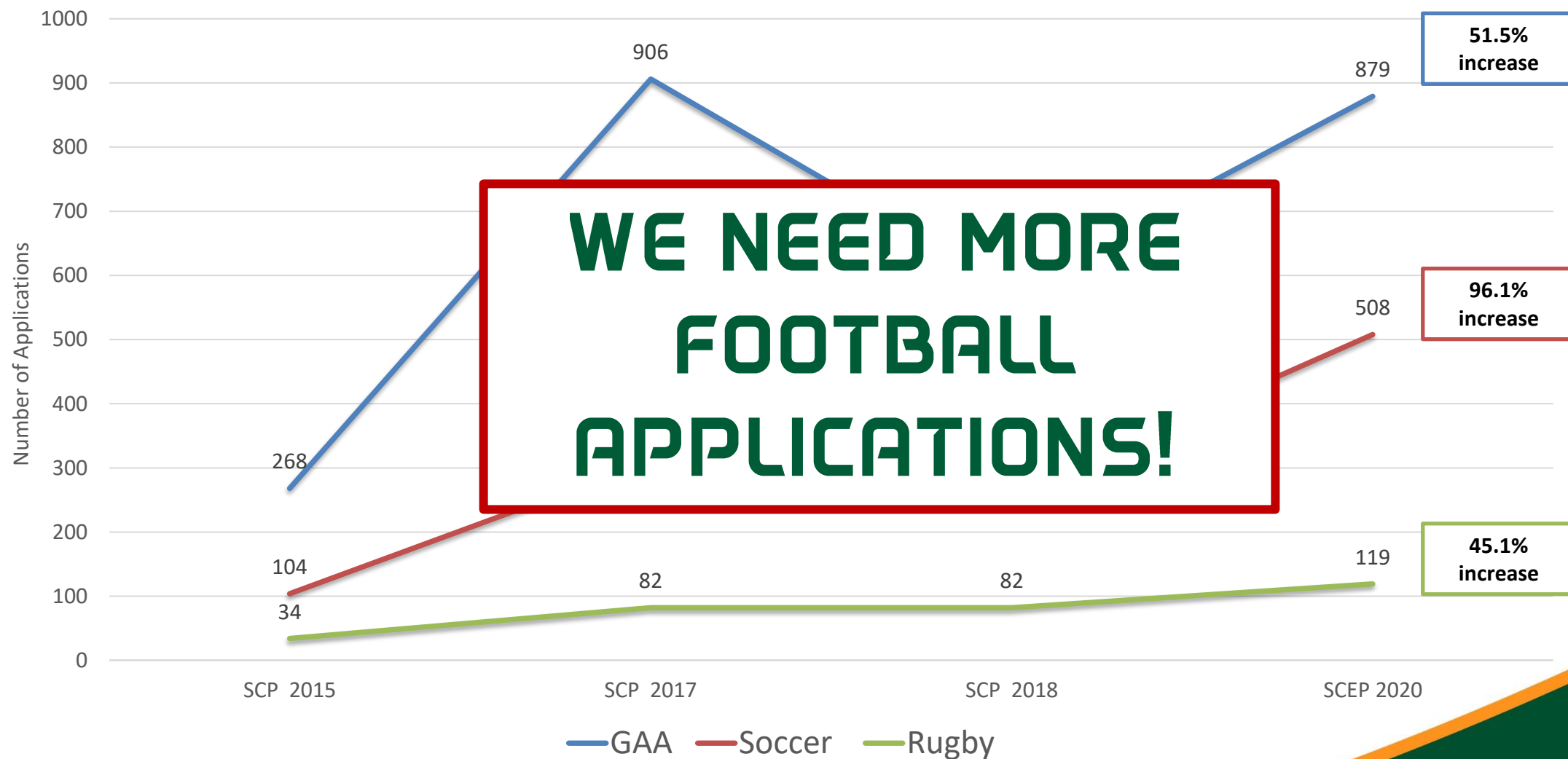
